3. That None of the calves mentioned overleaf have been exhibited in a MARKET before
4. The calves come from an officially Tuberculosis and Brucellosis free bovine herd which is not subject to official movement restrictions
5. All cattle over 42 days of age moving from within a 1 or 2 year TB testing parish must have had a negative TB test within 60 days of the date of movement to sale (the certificate must accompany the animals to the sale). Vendors presenting cattle from such areas, that have not had a negative TB test, will be liable to prosecution.

6. I, the owner/owner's agent, have examined the stock and have seen no signs of FMD or other Notifiable Disease
